do hereby make oath and state the following:



THE PARTIES

4. The main founding affidavit was finalised and commissioned at Pretoria on 24 May 2021.
5. Subsequent to the commissioning of the main founding affidavit – but before the service of the application to any of the respondents – the applicant became aware of the potential interest of the Sedibeng Water Board.
6. On 26 May 2021 I was informed that the Sedibeng Water Board in fact supplied certain bulk water services to the fifth respondent.



7. The notice of motion to the application is accordingly amended to include the Sedibeng Water Board as the tenth respondent.
8. The tenth respondent is the Sedibeng Water Board, a state owned entity and water board established in terms of section 29 of the Water Services Act 108 of 1997 with primary address at Delmay Street, Hartswater, Northern Cape.
9. As with the seventh to ninth respondents, the tenth respondent is joined because it might have a potential interest in the outcome of the application. No cost order is sought against the tenth respondent. A cost order will only be sought in the event of the tenth respondent electing to oppose this application.




