REQUEST TO REPORT ON IMPLEMENTATION OF ALIGNED SERVICES (LICENSES, PERMITS, AUTHORISATIONS, GRANTS, INCENTIVES, ETC.) AS PER APPROVED AGRIBEE ENFORCEMENT GUIDELINES.

The Director General wrote letters to request line function Directorates, Provincial Departments of Agriculture (PDAs) and State-Owned Entities (SOEs) to align their regulations and services in accordance with the approved AgriBEE Enforcement Guidelines. Alignment of services are in line with Section 10 of the BBBEE Act, which states that all government departments and institutions must include BBBEE criteria when allocating licences, issuing certificates and permits, authorizations, approving grants for funding projects.


DAFF's D: BBBEE Charters Compliance developed a reporting template intended to assist administrators of levers or services within the Department, PDA's and SOE to report on implementation of their aligned services. The attached reporting template serves as guide on the type of information required to enable DAFF to monitor the status of implementation by regulators of aligned services or levers. Section 13G of the BBBEE Amendment Act requires all spheres of

government, public entities and organs of state to report their compliance to BBBEE in their audited financial statements and annual report.

Your organisation is requested to report quarterly on its implementation of aligned services or levers using the reporting template provided. Furthermore, you should also submit the valid BBBEE certificates of applicants with your quarterly reports. The reports must be submitted one (1) week after the end of each quarter to RudolphA@daff.gov.za
